## Reg.: REACH - New European Unions Regulation for Chemicals coming into effect

Dear Sirs,

You may know by media publishing, that the parliament of the European Union (EU) in Strasbourg passed the new regulation for chemicals named REACH on December, 18th 2006.

REACH = Registration, Evaluation, Authorisation and Restriction of Chemicals

The Reach Regulation was published as Regulation (EC) No. 1907/2006 in the official gazette of the EU on December, 30th 2006. It came into effect on June, 1st 2007 and constitutes the framework for the stipulated activities with regard to the use and handling of chemical substances. As manufacturer of Printing Inks (downstream user) we are concerned indirectly by this new regulation.

The Reach Regulation stipulates the EU manufacturers and importers – with some exceptions only – to register all substances with a volume of more than one tonne per year at the European Chemicals Agency (EChA). We would like to stress, that the duty of registration does not concern the Printing Inks itself, but the used raw materials/substances.

The general obligations for EU manufacturers and importers and the ultimate date for the registration are graded in dependence on the volume and the hazardous potential of the substance (see timetable). Nevertheless all concerned substances have to be preregistered in the time from June, 1st 2008 till November, 31st 2008.

The registration process has to be finished latest on June, 1st 2018.

Passing of the REACH-Regulation (EC) No. 1907/2006: 18.12.2006 Coming into effect: 01.06.2007

Installation of the European Chemicals Agency (ECHA): 01.06.2007 - 1.06.2008 Pre-registration of Substances 01.06.2008 - 30.11.2008

Registration of Substances in three steps: till 30.11.2010

till 01.06.2013 till 01.06.2018
